



- The humber of Trustees shall not be more than eleven. The number of Trustees can only be increased only on unanimous consent of all the Trustees.
- The Trustees shall meet at a regular interval for conducting the business of the Trust and frame necessary rules for quorum and conduct of Trust meetings.
